#### 7. Clerk's Report

The Clerk reported that the invoices for the Newsletter adverts have been sent out, the advertising signs have been reported to SODC and the damaged bin has been reported to Biffa. The Clerk has appealed against Penalty Notice from HMRC.

The Council agreed to pay a part share of the cost for the Clerk to attend a Finance Course run by OALC.

### 8. Update on Core Strategy

Cllr Butler attended the EIP and spoke to oppose development to the South of Didcot towards the Hagbournes.

#### 9. Agree response to Amendment to Planning Application P10/W1959

Construction of 159 dwellings; informal open space; new means of vehicular and pedestrian access onto Park Road and associated infrastructure (As amended by revised scheme on layout accompanying letter from Agent dated 21 October 2011). Land at Park Road Didcot. The Council agreed to object to this section being built now as it is out of phase. It should be completed when the rest of the infrastructure is in place as Park Road is not suitable for construction traffic. It was also agreed that the Council needs to consult with residents about the proposed traffic calming in West Hagbourne as it was felt that cobbles are unsuitable.

#### 10. Discuss and Decide on traffic calming scheme

Various traffic calming methods were discussed (gates, light up speed signs, chicane, 20mph limit and slowing traffic in Park Rd). It was agreed to consult with residents about the best method.

# 11. Appoint Committee for Employment Issues

Cllrs Setch and Butler were appointed.

## 12. Appoint Planning Committee

Cllrs Brownsword, Butler, Lewis and Thornhill were appointed. It was agreed that Planning Meetings should be held in public.

### 13. Discuss Employment Contract and Policies on Employment Issues

Cllrs Setch and Butler will confirm the Clerk's Contract.

### 14. Discuss Standing Orders

Cllr Butler is hoping to adapt East Hagbourne's Standing Orders.

#### 15. Discuss Parish Plan

The current Parish Plan runs out this year. Parish Plans are about to be replaced with Neighbourhood Plans as part of the Localism Bill. It was agreed to publish an explanation of the Plan on the website and in the Newsletter in order to gauge interest.

It was agreed that the Parish Council archive including the Enclosure Award should be stored with the History Society archive. The History Society is currently discussing storage with both Didcot Library and The Oxford History Centre.
