- South & Vale have provided notification of uncontested election costs; the Parish Council will be invoiced for £85.00 shortly.
- The grant for £600.00 from South & Vale for the defibrillator project still hasn't arrived in the Parish Council accounts. The Grant Team Leader (Carole Cumming) is aware of the delay and is working on resolving the matter as soon as possible; Clerk to monitor and follow-up as required.
- The village website domain name has been renewed for a further 5 years.

10. Planning:

(i) 'Silva Felix' follow-up:

Cllr Brownsword reported that someone from the council has visited the property and advised about disposal of asbestos sheeting. The building work is currently on hold, possibly for building regulations input. Parish Council to continue to monitor.

(ii) Proposals for roundabout on A417 (Lighting etc.):

A planning application has been made for lighting along the planned link road from Harwell to the new roundabout near The Kingswell Hotel. The Council feel that this is inappropriate for a rural road and decided to object to the provision of lighting along the entire link road; objection to be submitted by Clerk.

11. Changes to subsidised Buses and Dial-a-Ride: See point 3 above (Public Participation).

12. Correspondence:

- The grant from the County Council for the mini-bus service to East Hagbourne Primary School is reputedly being cut. The parents for one of the affected children have written to the Council to object to this on several grounds. The Council generally agreed to support the objections to cut the service, Cllr Bannister to draft a letter in support of the parents on behalf of the Parish Council.
- East Hagbourne Parish Council has queried whether we have any records that West Hagbourne own part of the Cemetery. This is in relation to a review of the current financial process for the cemetery (i.e. funds all currently go through the East Hagbourne books for audit and VAT purposes); Clerk to check records.

13. Newsletter Report:

Cllr Bannister will draft a short piece for the newsletter to alert villagers to the planned cut of the primary school mini-bus and to say that the Parish Council supports the opposition of this plan.
