#### Community Infrastructure Levy (CIL) Grant Fund

South Oxfordshire District Council will soon be launching a <u>new grant scheme</u> called the Community Infrastructure Levy (CIL) Grant Fund. Town and parish councils and not for profit community groups and organisations will be able to bid for between £75,000 to £250,000 for a wide range of infrastructure to support existing or planned future growth in the district. The council collects CIL funding from liable developments in order to deliver the infrastructure required to support growth in the district. Through this pilot scheme, we're helping to fund local organisations to deliver infrastructure for their community required as a direct result of development.

#### **Eligibility:**

You can find more information about the <u>Grant Fund and view the full eligibility criteria online</u>, a few points to note:

The fund is available to town and parish councils and not for profit community groups and organisations only.



- Proposed projects need to have a genuine focus on providing the infrastructure needed as a result of development and must be delivered in the South Oxfordshire District Council area.
- Proposed projects must adhere to the CIL spending requirements as set out in the regulations the fund may only be used to support the actual delivery of physical infrastructure. It can be new infrastructure or improve or expand the reach of existing infrastructure. It is not able to cover costs for scoping or pre-planning of projects.
- We will prioritise projects that support our corporate priorities and other key criteria to ensure deliverability, sustainability, inclusivity and consideration towards the climate and ecological impacts.

#### How to apply:

You'll soon be able to submit an Expression of Interest (EOI) from **week commencing 19 February 2024.** The EOI stage will be open for six weeks and you can view the <u>guidance materials</u> now to help prepare. We will be in touch again once submissions open. Following the EOI process, applicants whose projects meet the funding requirements will be invited to submit a full application.

#### Didcot Wave flexes new gym equipment

South Oxfordshire District Council has just upgraded the gym at Didcot Wave Leisure Centre to the tune of £130,000 with new state-of-the-art cardio and resistance equipment.

It's not just good news for those trying to get fit and healthy – it's also great news for the climate with some new equipment being powered by human energy rather than by electricity. These self-powered gym stations help reduce the energy consumption and therefore operational costs at Didcot Wave.

The refurbishment covered a full replacement of kit, including 57 new machines from bench presses, bikes and rowing machines to free weights and an Olympic Power Rack, as well as new flooring and lighting. It was largely funded from payments by developers which have built homes in the area, known as Section 106 funding, with some additional capital funding from the council.

#### New planning rules mean good news for nature recovery

New planning rules came in across the country which will mean those looking to build a new development must include wildlife enhancements as part of their plans.



Developers in England will have to deliver at least ten per cent Biodiversity Net Gain (BNG) when building new housing, industrial or commercial developments. This means that by law they must replace any biodiversity lost to the development plus an additional 10 per cent by creating new habitats.

BNG – which came into law nationally on 12 February – is not a new concept for South Oxfordshire and Vale of White Horse District Councils, whose officers have been working on similar approaches to enhancing the wildlife value of new developments since becoming the first authorities in the UK to successfully secure a BNG agreement in 2013.

#### What BNG means for developers of sites (large or small)

- To achieve BNG developers must first survey their sites before work starts to measure its biodiversity value.
- When submitting plans for a new development they must show they can replace the value of the habitats lost as well as provide a 10 per cent increase in wildlife value of the site (before work begins)
- Where this is not possible on-site they must provide habitats offsite.

Where offsite habitat is required, this can be provided on other land owned by a developer, in agreement with third parties, or through the purchase of credits.

South Oxfordshire and Vale of White Horse District Councils have already been working with local nature organisations such as the Trust for Oxfordshire's Environment (TOE) and Buckinghamshire, Berkshire and Oxfordshire Wildlife Trust (BBOWT) to create new habitats that can be made available to developers who require biodiversity offsets. This ensures any BNG requirements caused by development in our districts benefit our local wildlife.

#### Successful recycling districts urge residents to reduce and reuse before recycling

Residents in South Oxfordshire are officially the best recyclers in the country, with residents in the Vale of White Horse a close third, according to a government league table published yesterday.

However, both districts are now encouraging residents to further boost this good work by turning their efforts to reducing and reusing where possible.

The Department for Environment Food and Rural Affairs (Defra) officially published the <u>recycling</u> <u>performance league table</u> yesterday (Wednesday 31 January). South Oxfordshire and Vale of White Horse District Councils were placed in the top three of the recycling tables for English local authorities. South



Oxfordshire had been ranked the highest for household waste recycling rates in 2022/23 at 61.6% and Vale of White Horse in third place with 60.9%. Each council has been in the top 5 for the last five years.

Alongside the high performing collection rates for both councils, locally, a recent waste satisfaction survey has yielded encouraging results for the councils' household waste collections, indicating a high level of resident approval with this side of the service. An impressive 82% of respondents expressed satisfaction, or high satisfaction, with the overall quality of the waste and recycling services provided.
